Poll results for Annual General Meeting held on 24 May 2024

At the annual general meeting of Chinese Estates Holdings Limited (the “**Company**”) held on 24 May 2024 (the “**AGM**”), all the proposed resolutions set out in the notice of the AGM dated 30 April 2024 (which was incorporated in the circular of the Company dated the same date (the “**Circular**”)) were duly passed by the shareholders of the Company by way of poll demanded by the chairman of the meeting.

As at the date of the AGM, a total of 1,907,619,079 shares of the Company were in issue and entitled the holders of which to attend and vote at the AGM. There was no restriction on shareholders to cast votes on the proposed resolutions at the AGM. None of the shareholders of the Company has indicated in the Circular that he/she intends to abstain from voting on or vote against any of the resolutions at the AGM.
